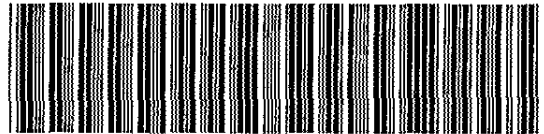

The undersigned, acting as incorporator of Entertainment Industry Seminars, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is:

Entertainment Industry Seminars, Inc.

**ARTICLE II. ADDRESS**

The initial mailing address of the corporation, and the address of the corporation's initial principal office, is 1120 Hideaway Drive North, Jacksonville, Florida 32259.

**ARTICLE III. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

**ARTICLE IV. PURPOSE**

The corporation is organized to engage in the business of producing seminars relating to the entertainment industry, engage in activities related thereto, and to engage in any other activity or business permitted under the laws of the United States and Florida.

**ARTICLE V. AUTHORIZED SHARES**
