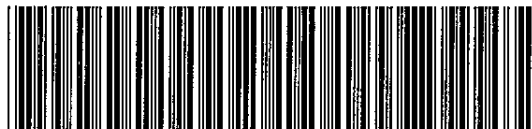

ARTICLES OF INCORPORATION
OF
SADDLE CREEK TRANSPORTATION, INC.

ARTICLE I. - NAME

The name of the corporation is **SADDLE CREEK TRANSPORTATION, INC.** The address of the principal office of this corporation shall be 3010 Saddle Creek Road, Lakeland, Florida 33801, and the mailing address shall be 3010 Saddle Creek Road, Lakeland, Florida 33801.

ARTICLE II. - DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of the State of Florida.

ARTICLE III. - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of \$1.00 par value common stock which shall be designated "common shares".

ARTICLE V. - PREEMPTIVE RIGHTS

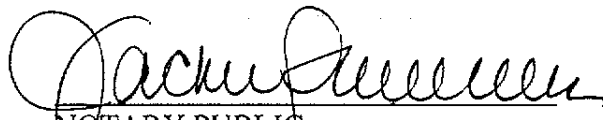
