1. The name of this Corporation is Sweet Additions, Inc. and the Corporation was originally incorporated on August 13, 2003 pursuant to the FBCA.
2. The Articles of Incorporation of the Corporation, originally filed on August 13, 2003, are hereby amended to delete ARTICLE 1. Name in its entirety and substitute the following in lieu thereof:

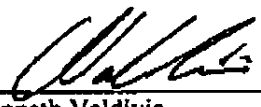
"ARTICLE 1. Name
