ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is Jerky's Authentic Restaurant of Brevard, Inc. at 1516 Palm Bay Road NE, Palm Bay, FL 32905 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.
