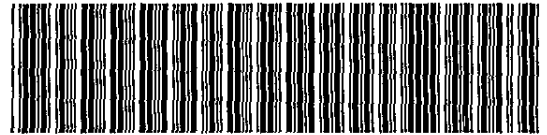

**ARTICLE I
NAME**

The name of this corporation ("Corporation") is GROHMANN TECHNOLOGIES GmbH, INC..

**ARTICLE II
DURATION**

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

**ARTICLE III
PURPOSE**

The corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV
INITIAL PRINCIPAL OFFICE**

**ARTICLE V
SHARES**

The total number of shares which the corporation shall have authority to issue is 1,000 shares with a part value of \$0.10 per share.

Any director or officer who is involved in litigation or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.

ARTICLE X OTHER PROVISIONS

Corporation Type. This corporation and each subscriber hereto shall take whatever action shall be necessary to cause the shares of the corporation issued to qualify as "Section 1244 stock" and, further this corporation and each subscriber hereto shall take whatever action is necessary to cause the corporation to file an election to become a Subchapter S corporation, as such terms are used and defined in the Internal Revenue Code of 1952, as amended.

In the absence of fraud, no transaction between (a) this corporation and (b) any other association, corporation or any director or officer of this corporation individually, shall be affected by the fact that any director or officer of this corporation is individually a party to the transaction or is interested in or is a director or officer of such other association or corporation.
