ARTICLES OF INCORPORATION  
OF

CROWN FINANCIAL SERVICES CORPORATION

The undersigned, acting as an incorporator of a corporation under Chapter 607, Florida Statutes, the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I

Name
