ARTICLE I - NAME AND ADDRESS

The name of this corporation is ICF GP, INC. (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 2000 PGA Boulevard, Suite 2202, North Palm Beach, Florida 33408.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.
