**ARTICLES OF INCORPORATION
of

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I: The name of this corporation is **Standard Land Company**.

ARTICLE II: This corporation shall exist for perpetuity commencing on the date of execution of these Articles.

ARTICLE III: This corporation is organized for the purpose of providing real estate development services, and for any and all lawful business allowed under the laws of the State of Florida and/or the United States of America.

ARTICLE IV: This corporation is authorized to issue 1,000 shares of common stock, with a par value of \$1.00 each.

ARTICLE V: The street address of the initial registered office of this corporation is **64 Dolphin Dr., St. Augustine, Florida 32080**, and the name of the initial registered agent at that address of this corporation is **BERNARD M. FERTIG**.

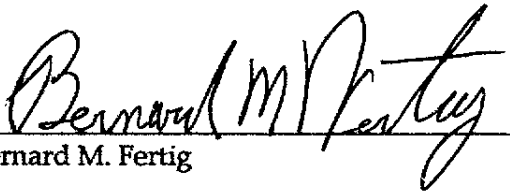

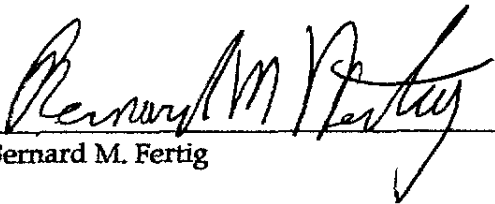
