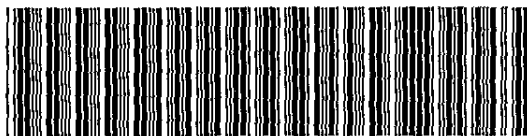



ARTICLES OF INCORPORATION

ARTICLE I: NAME

The name of this Corporation is MY A C & HEATING, INC.


