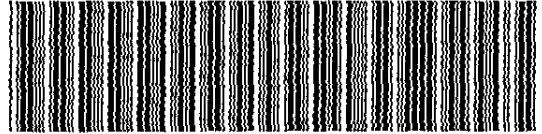



ARTICLES OF INCORPORATION

ARTICLE I: NAME

The name of this Corporation is MY A C, INC.

ARTICLE II: PURPOSE

ARTICLE XII: DISSOLUTION

In the event of dissolution, the assets of the Corporation shall be distributed to the stockholders.


