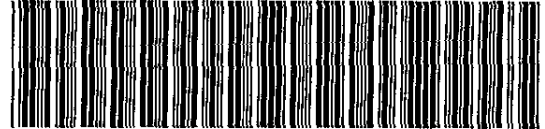

ARTICLES OF INCORPORATION

OF

ARTICLE I.

NAME

The name of this corporation is Tampa Bay Escorts, Inc.


ARTICLE X.
