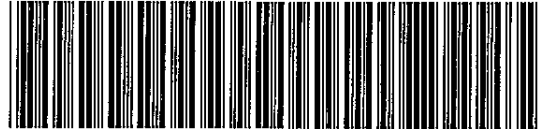

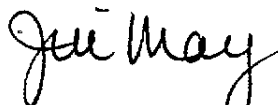

ARTICLE I - NAME

The name of this corporation is HOSPITALITY SERVICES OF OCOEE, INC.

ARTICLE II - ADDRESS

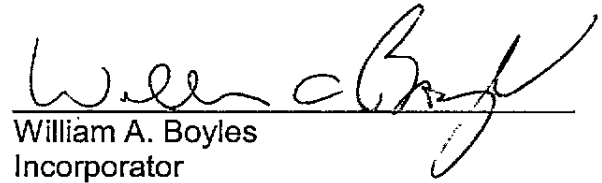
ARTICLE IX - BYLAWS

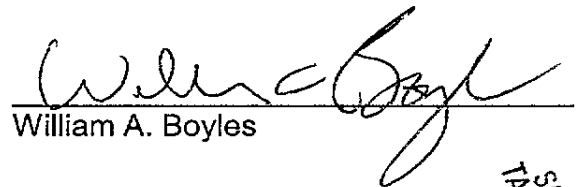
