ARTICLES OF INCORPORATION

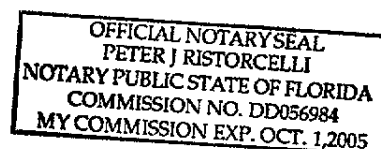
