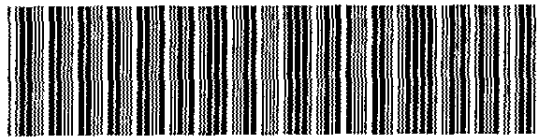

ARTICLE I.

NAME

The name of this corporation is: **Michel Gehain Fine Arts & Antiques, Inc.**

ARTICLE II.

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is: **1014 Teal Pointe, Tarpon Springs, Florida 34689.**

ARTICLE III.

DURATION: EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of the date of filing with the Secretary of State.

ARTICLE IV.

PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE V.
CAPITAL STOCK

This corporation is authorized to issue **One Thousand (1,000)** shares of **One Dollar (\$1.00)** par value common stock.

ARTICLE VI.
