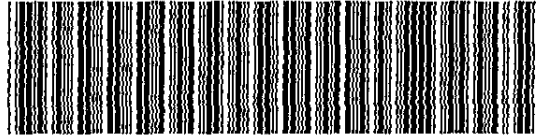

ARTICLE ONE

The name of the corporation is **KING JANITORIAL SERVICES, INC.** The principal address of the corporation is: 4971 SW 7th Court, Margate, Florida 33068.

The period of its duration is perpetual.
