

ARTICLES OF INCORPORATION OF

BOTTOMTIME ADVENTURES, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is BOTTOMTIME ADVENTURES, INC.

ARTICLE TWO

DURATION

The term of existence of the Corporation is perpetual.

PURPOSE
