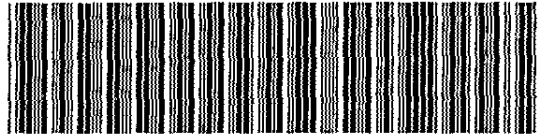

ARTICLES OF INCORPORATION

for

PRICELESS DRY CLEANERS, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. Name: The name of the corporation is PRICELESS DRY CLEANERS, INC. The address of the corporate office shall be 5405 Monterey Circle, Apt. 26, Delray Beach, FL 33484.

ARTICLE II. Duration: The period of this corporation's duration is perpetual.

ARTICLE III. Purpose: The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida, including dry cleaning services and related activities, within and without the State of Florida.
