**ARTICLE I
NAME**



DIRECTOR LIABILITY AND INDEMNIFICATION

The Corporation may, to the full extent permitted by Florida Law, indemnify any person who is or was an employee or agent of the Corporation or was serving at the request of the Corporation as an employee or agent of another corporation, partnership, joint venture, trust or other enterprise.
