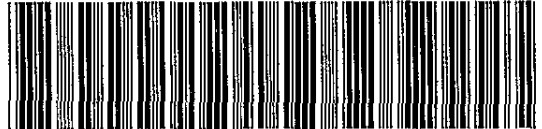



ARTICLES OF INCORPORATION
OF

ARTICLE I
NAME

The name of the corporation is FLORIDA ELITE REALTY, INC. The address of the corporation is 4823 FOXSHIRE CIR. TAMPA, FLORIDA 33624.

ARTICLE II
DURATION

The corporation shall have perpetual existence.

ARTICLE III
PURPOSE
