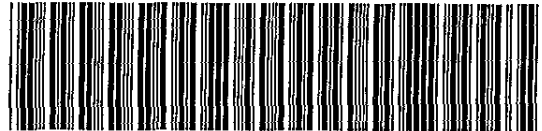


**ARTICLE VII-Date of Existence**

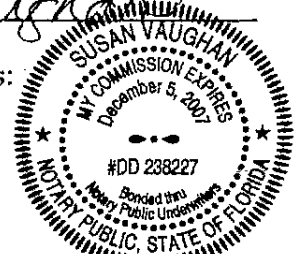


