I, the undersigned officer and director of YJNK IV, Inc., a Florida corporation-for-profit, hereby certify that the following Amendment to the Articles of Incorporation was duly adopted by the Board of Directors and shareholders of the corporation at meetings held by them upon due and proper notice. The number of votes cast for the amendment were sufficient for approval on November 26, 2003.

AMENDMENT

1. The present name of the corporation is "YJNK IV, Inc." The name of the corporation is hereby changed to "Able Group, Inc." Article I of the Articles of the Incorporation is amended to read as follows:

ARTICLE I. NAME

The name of the corporation shall be: "Able Group, Inc."
