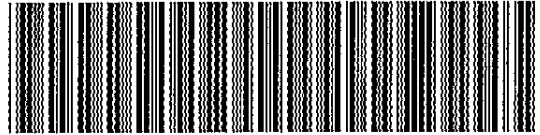


ARTICLE VII-Date of Existence


