This corporation is to exist perpetually.

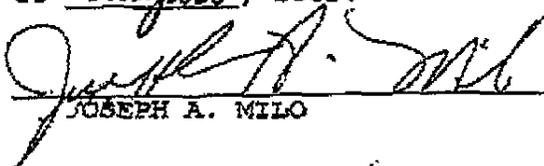
ARTICLE VI - INCORPORATOR

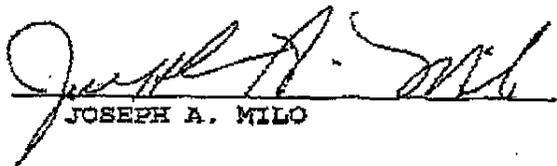
