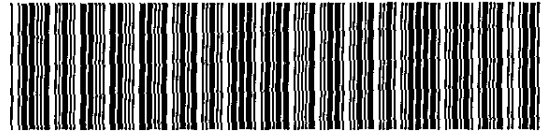


## **ARTICLES OF DISSOLUTION**
