AMENDED AND RESTATED ARTICLES OF INCORPORATION OF 15 MINUTES OF FAME, INC.

ARTICLE L Name

The name of the corporation (hereinafter referred to as the "Corporation") is:

15 Minutes of Fame, Inc.

ARTICLE IL Principal Offices and Mailing Address

The principal office and mailing address of the Corporation is 4705 95th Street North, Suite B, St. Petersburg, Florida 33708.

The Corporation shall indemnify to the full extent permitted by law any person who is made, or is threatened to be made, a party to any action suit or proceeding (whether civil, criminal, administrative, or investigative) by reason of the fact that he or she is or was a director or officer of the Corporation or serves or served any other enterprises at the request of the Corporation. If the Florida Business Corporation Act is amended after the filing of these Amended and Restated Articles of Incorporation of which this Article VI is a part to authorized corporate action further eliminating or limiting the personal liability of directors, then the liability of a director of the corporation shall be eliminated or limited to the fullest extent permitted by the Florida Business Corporation Act as so amended.

Any repeal or modification of the foregoing paragraph by the shareholders of the Corporation shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.

ARTICLE VIL. Amendment

The corporation reserves the right to amend, alter, change, or repeal any provision contained in these Amended and Restate Articles of Incorporation in the manner now or hereinafter prescribed by the laws of the State of Florida. All rights, powers, privileges, and discretionary authority granted or confessed herein upon shareholder or directors are granted or confessed subject to this reservation.
