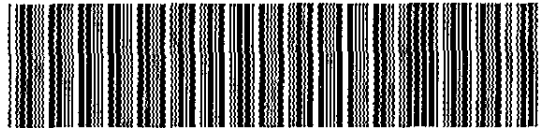

The undersigned Incorporators for the purpose of forming a corporation pursuant to Chapter 607 Florida Statute hereby adopt(s) the following Articles of Incorporation under the Florida Corporations Act.

ARTICLE I – NAME

Dissolution of the Corporation shall only be by resolution of the Board of Directors or an act of law.

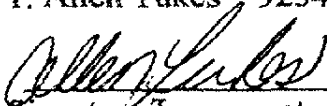
ARTICLE IX – LIFE OF CORPORATION

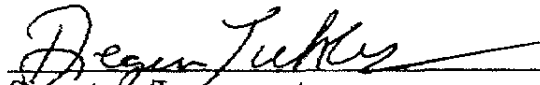
Life of the corporation will be perpetual unless dissolved by an act of law or the Board of Directors.
