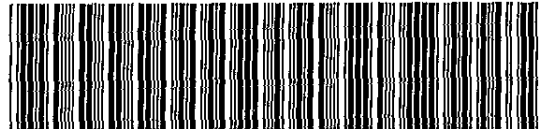


ARTICLE VIII: SPECIAL PROVISION
