The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I.

The name of this corporation shall be: **SOUTH FLORIDA MOBILE TRUCK REPAIR, INC.**

ARTICLE II.

The principal place of business of the corporation shall be: 3675 W. 11th Avenue, Apartment #207, Hialeah, Florida 33012.

ARTICLE III.

The purpose is to engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV.

The capital stock of this Corporation shall consist of One Hundred (100) shares of common stock. There shall be no par value per share.
