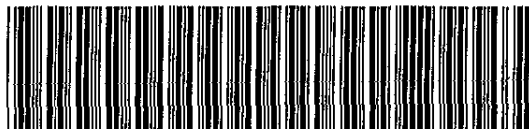

I, the undersigned Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is THE EDUCATION ACADEMY, INC. (the "Corporation").

ARTICLE II. NATURE OF BUSINESS

The purpose of the Corporation shall be to engage in such business and business activity as are permitted and otherwise allowable by law.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at one time is one thousand (1,000) shares having a par value of one (\$0.01) per share.

ARTICLE IV. ADDRESS

The principal office of the Corporation shall be located at 601 Cypress Lake Boulevard, No. F, Pompano Beach, Florida 33064, and its Registered Agent is Aysha Abdullah, 601 Cypress Lake Boulevard, No. F, Pompano Beach, Florida 33064.

ARTICLE V. DIRECTORS

The Corporation shall have at least one (1) director, with the exact number of directors to be specified by the By-laws adopted by the shareholders from time to time unless the shareholders shall, by a majority vote hereafter, determine that the Corporation be managed by the shareholders. The initial number of directors shall be one (1).

ARTICLE VI. EXISTENCE

The Corporation shall have perpetual existence.

#### ARTICLE VII. INCORPORATOR

The name and post office address of the Incorporator of these Articles of Incorporation is Aysha Abdullah, 601 Cypress Lake Boulevard, No. F, Pompano Beach, Florida 33064.

#### ARTICLE VIII. BY-LAW AMENDMENT

The power to adopt, alter, amend or repeal the By-laws of the Corporation shall be set forth in the By-laws of the Corporation.

#### ARTICLE IX. INFORMAL ACTION OF DIRECTORS

If any of the directors severally or all of the directors collectively consent in writing to any action taken or to be taken by the Corporation, and the writings evidencing their consent are filed with the Secretary of the Corporation, the action shall be valid as though it had been authorized at a meeting of the Board of Directors.

#### ARTICLE X. DIRECTORS

The name and address of the initial director of the Corporation is Aysha Abdullah, 601 Cypress Lake Boulevard, No. F, Pompano Beach, Florida 33064.

#### ARTICLE XI. MEETING BY CONFERENCE TELEPHONE


Members of the Board of Directors may participate in meetings of the Board of Directors by means of conference telephone as provided by law.
