The undersigned person(s), acting as incorporator(s) of a corporation organized under the laws of Florida, hereby adopt the following Articles of Incorporation:

**ARTICLE I.  
NAME**

The name of this corporation is RANCH AMADEUS COMPANY, ( hereinafter called the "Corporation"), and its initial principal mailing address is located at 1605 S. US Highway, V 4 - 205, JUPITER, FL 33477, with the privilege of establishing and maintaining such other place or places of business and offices and agencies elsewhere in the State of Florida, and in any other state of the United States other than the State of Florida, as the Corporation may hereinafter desire and determine.

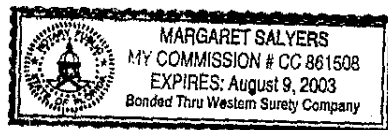


