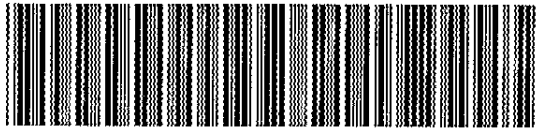

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I: NAME AND ADDRESS**

The name of the corporation shall be MOORE AND DOBLER PROPERTIES, INC. The street address of the principal office of the corporation is 1547 Florida Mango Road North, Building 11, Suite 2, West Palm Beach, Florida 33409. **ARTICLE II: NATURE OF BUSINESS**

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
