**ARTICLE I. PREAMBLE**

The undersigned natural person, competent and licensed to practice dentistry in the State of Florida acting as Incorporator for the purpose of forming a professional service corporation for profit under the provisions of Chapters 607 and 621, Florida Statutes, does hereby adopt the following Articles of Incorporation.

**ARTICLE II. PURPOSE**

The general nature and purpose of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of dentistry, and all its fields of specializations, as are engaged in by law.
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be doctors of dentistry in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.
- c. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
