The undersigned incorporator to these Articles of Incorporation hereby associates to form a corporation (the "Corporation") under Chapters 607 and 621 of the Florida Statutes.

1. Name

The name of the Corporation is Burton P. Golumbic, DDS, PA The Corporation's principal office (and mailing address) is located at 3376 Woods Edge Circle, Suite 101, Bonita Springs, Florida 34134 in Lee County, Florida. The Board of Directors may from time to time move the principal office of the Corporation to any other address in the State of Florida.

2. Nature of Business
