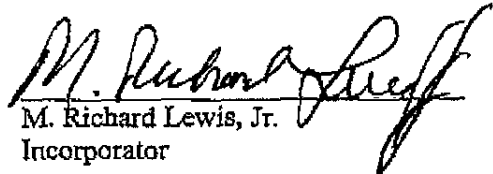
ARTICLE VII-BYLAWS
