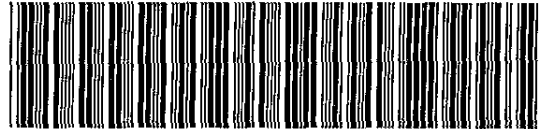

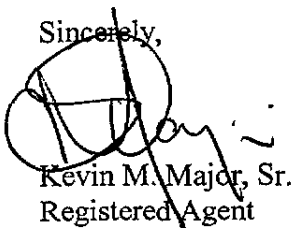

The name of the corporation is KEVMAR FINANCIAL GROUP, INC.

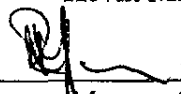

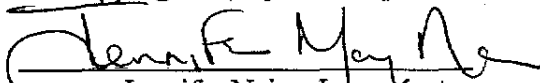

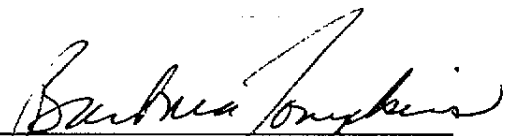
