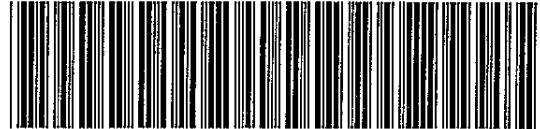

ARTICLES OF INCORPORATION

We, the undersigned, as proper persons acting as incorporators of a perpetual corporation under the laws of the State of Florida, adopt the following articles of incorporation:

ARTICLE I - NAME

The name of the corporation shall be: NORRIS EXTERMINATING, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business/mailling address is: 606 B 17th Street East, Palmetto, Florida 34221.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and of the State of Florida; including pest control and prevention.

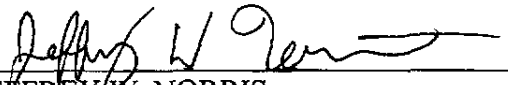
