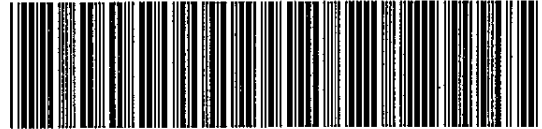

**ARTICLE I NAME**

The Corporation shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Corporation, unless the business of the Corporation is continued by the consent of all the remaining members.

The Corporation shall be managed by Managers in accordance with regulations adopted by the members for the management of the business and affairs of the Corporation. These regulations may contain any provisions for the regulation and management of the affairs of the Corporation not inconsistent with law or these articles of incorporation.






