

ARTICLES OF INCORPORATION
OF

The undersigned, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - NAME

The name of the Corporation is **Southside Cellular, Inc.**

ARTICLE II - PRINCIPAL BUSINESS ADDRESS

The principal place of business and mailing address of the Corporation is 1825 South Adams Street, Tallahassee, Florida 32301.

ARTICLE III - COMMENCEMENT AND DURATION

The Corporation is to commence its corporate existence on the date of subscription and acknowledgment of these Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE IV - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE V - STATED CAPITAL

The Corporation is authorized to issue ten-thousand (10,000) shares of one dollar (\$1.00) par value common stock. Each outstanding share, regardless of class shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the shareholders.

ARTICLE VI - PREEMPTIVE RIGHTS

Each shareholder, upon the issuance or sale of either new or treasury stock for cash, property, or services, in payments of either corporate debts or otherwise, shall have the right to purchase his or her proportionate share thereof.

The shares of stock may be issued for such consideration, having a value not less than the par value of the shares issued therefor, as is determined from time to time by the Board of Directors, to be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation. Shares may not be issued until the full amount of the consideration therefor has been paid. Thereafter, such shares shall be deemed to be fully paid and nonassessible.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is Charles J. Reed & Associates, CPA's, 2828 Remington Green South, Tallahassee, Florida 32308, and the name of the initial registered agent of the Corporation at that address is CHARLES J. REED, CPA.

ARTICLE VIII - BOARD OF DIRECTORS

All corporate powers shall be exercised by and under the authority of, and the business

and affairs of the Corporation shall be managed under the direction of the Board of Directors.

Any and all of the powers and duties conferred to or imposed upon the Board of Directors, by resolution of the shareholders adopted at a special meeting called for that purpose, may be exercised or performed to such extent and by such person or persons as shall be provided by the shareholders.

The Corporation shall have one director initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the By-Laws of the Corporation, but shall never be less than one. The name and address of the initial director of the Corporation is:

ARTICLE IX - INDEMNIFICATION

The Corporation shall indemnify and hold harmless any present or former officer or director, or person exercising the duties of an officer or director at the request of the Corporation, to the full extent now or hereafter permitted by law.

ARTICLE XI - BYLAWS

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders, but the Board of Directors may not alter, amend or repeal any By-Laws adopted by the shareholders if the shareholders provide that the By-Laws shall not be altered, amended, or repealed by the Board of Directors.

ARTICLE XII - AMENDMENT

These Articles of Incorporation may be amended at any time by a vote of the majority of the voting stock of the Corporation outstanding, at any regular meeting of the stockholders or at any special meeting of the stockholders called for that purpose.
