ARTICLE 3. ADDRESS. The principal place of business and mailing address of this corporation shall be 3206 South Conway Road, Orlando, FL 32812.


ARTICLE 4. STOCK. The corporation is authorized to have outstanding at any one time 100 shares of stock at \$1.00 par value.


