

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

## **ARTICLE I - NAME**

The name of the Corporation is SUPER DUPER CLEANING COMPANY.

### **ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and the mailing address of the corporation is: 3973 S.W. Wycott Street, Port St. Lucie, FL 34953.
