ARTICLES OF INCORPORATION

OF

DSI FINANCIAL, INC.

ARTICLE I - NAME

The name of this corporation is DSI FINANCIAL, INC., and the mailing address shall be 7300 North Federal Highway, Suite 105, Boca Raton, Florida 33487.

ARTICLE II - DURATION

This corporation is to exist perpetually unless dissolved according to Florida law.

<u> ARTICLE III - PURPOSE</u>

The general nature of the business to be transacted by this Corporation is to engage in the practice of and to conduct any and all business or other lawful activity permitted under the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK
