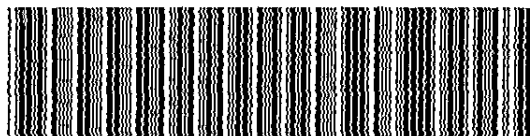


#### **ARTICLE IX – BY-LAWS**


