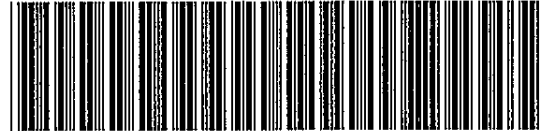

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is: CCYD, INC.

ARTICLE IX - COMMENCEMENT OF EXISTENCE


The corporate existence of the Corporation shall commence on the date of execution of these Articles of Incorporation.
