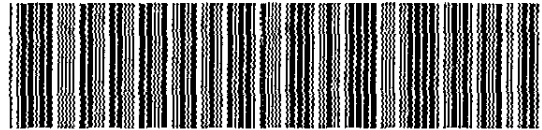


## ARTICLE XI AMENDMENT


