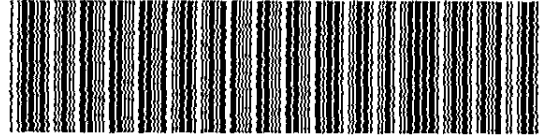

**ARTICLES OF INCORPORATION**

The undersigned hereby acting as incorporator for the purpose of forming a professional service corporation for profit, by virtue of the provisions of Chapters 621 and 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE 1: NAME AND ADDRESS**

**ARTICLE 2: DURATION**

This Corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of Florida.

**ARTICLE 3: PURPOSE**

This Corporation is organized for the purpose of engaging in the legal profession in the State of Florida.

**ARTICLE 4: CAPITAL STOCK**

This Corporation is authorized to issue 7500 shares of \$1.00 par value common stock. Shares of the Corporation's stock and certificates therefor shall be issued only to licensed attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this Corporation.

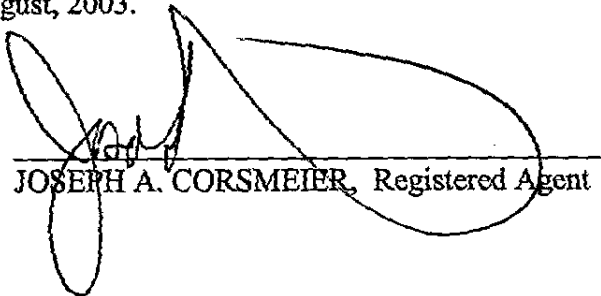
