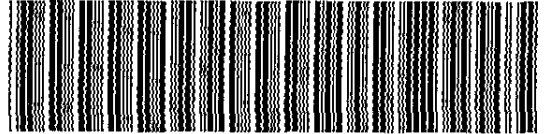

**ARTICLES OF INCORPORATION
OF
MACH ONE LEADERSHIP, INC.**

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is **MACH ONE LEADERSHIP, INC.**

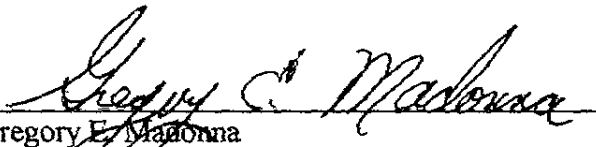
