ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be SIDEWINDER SALOON, INC., with its principal place of business at 4209 Southeast 5th Street, Ocala, Florida 34471.

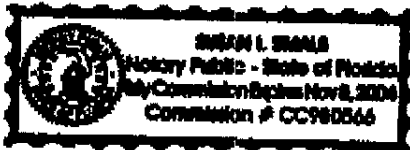
