ARTICLES OF AMENDMENT OF JEHOHANAN, INC.

BEFORE ME, an officer duly authorized to administer oaths, personally appeared MURRAWAT H. SAYED, who being well known to me, as Director and President of JEHOHANAN, INC., does hereby testify to the truth and accuracy of the following:

ARTICLE I

The present name of the corporation is JEHOHANAN, INC.

ARTICLE II

The Articles of Incorporation of JEHOHANAN, INC. filed August 27th, 2003, are to be amended as follows:

- 1. The purpose of the corporation is to engage in any lawful act or business activity that is directly related to the operation of Burger King Restaurants.
- 2. The number of holders of shares of voting common stock and the issuance and transfer of shares are restricted in accordance with the terms and conditions set forth in the corporation's by-laws.

ARTICLE III

The amendment of the Articles of Incorporation herein does not provide for an exchange, reclassification, or cancellation of issued shares.

ARTICLE IV

The amer dment referred to in Article II above, as adopted on August 10th, 2005 by unanimous vote of the shareholders and directors of JEHOHANAN, INC. MURRAWAT H. SAYED owning 80 shares, representing 80% of the issued and outstanding shares of the corporation, and MOHAMMED A. SAYED owning 20 shares, representing 20% of the issued and outstanding shares of the corporation, did vote in favor of the amendment referred to in Article II above. Further, MURRAWAT H. SAYED and MCHAMMED A. SAYED, as the only two directors of JEHOHANAN, INC., did also affirmatively vote to amend the Articles of Incorporation as referred to in paragraph 2 above. JEHOHANAN, INC., as of August 10th, 2005, contained only one

class of shares, which were voting shares, constituting 100 in number which are issued, 80 in favor of MÜRRAWAT H. SAYED, and 20 in favor of MOHAMMED A. SAYED.
