ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida Professional Service Corporation and Limited Liability Company Act.

ARTICLE I

CORPORATE NAME

The name of the corporation is David Tenzel, M.D., P.A., (hereinafter referred to as the "Corporation").

ARTICLE II

MAILING ADDRESS AND PRINCIPAL OFFICE

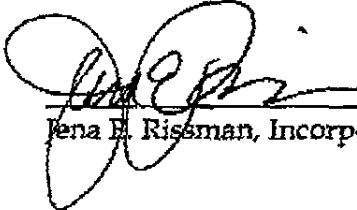

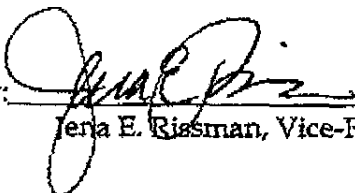
