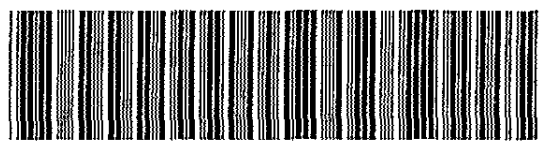



5. The registered agent of the corporation is Judith A. Richardson, and the registered address is: 1040 Seminole Bear Trail, Pierson, Florida 32180.




